Content of decisions made by issuer's Board of Directors: To determine that based on market value, price of services specified in Appendix to this decision shall equal RUB 499,900 (Four hundred ninety-nine thousand nine hundred). To approve signing of educational service contract between Gazprom and Saint Petersburg State University of Economics federal government funded institution of higher education as related-party transaction under terms listed in Appendix to this Board of Directors decision.</p> <p>2.3. Appendix to Board of Directors decision No. 2715 dated April 19, 2016. Main terms and conditions of service contract: Description of contract: rendering professional reeducation services “MBA Gazprom: Managing Oil and Gas Corporation in Globalized Environment” (two-year program composed of nine modules) for Alexey Veltistov, Gazprom specialist, according to approved Curriculum and Course Schedule for 2014–2016. Terms of service: from December 1, 2014 until November 25, 2016. Contract enters into force on date of its signing by parties and is valid until parties fulfill their obligations. Terms and conditions of contract shall, except for conditions of providing Gazprom with information on changes in ownership of Saint Petersburg State University of Economics federal government funded institution of higher education, apply to relations between parties starting from December 1, 2014.</p> <p>2.4.
