2. Contents of Statement

On ratification of transactions considered by Russian Federation law as major transactions and (or) related-party transactions

2.1. Quorum of Gazprom Board of Directors meeting and voting results on decision-making issues: 9 out of 11 elected Board of Directors' Members took part in meeting in absentia, quorum recorded as present. Voting results on agenda item "On approval of related-party transaction with SOGAZ-LIFE":

In favor – 9 out of 9 Board Members.

2.2. Content of decisions made by issuer's Board of Directors:

To determine that, based on market price calculated by National Rating and Consulting Agency, price of life insurance services to be provided by SOGAZ-LIFE (insurance premium for insured persons) to Gazprom shall equal RUB 24,289,438 (Twenty-four million two hundred and eighty-nine thousand four hundred and thirty-eight rubles). To ratify conclusion of life insurance contract between Gazprom and SOGAZ-LIFE as related-party transaction under terms listed in appendix to Board of Directors' Decision.

2.3. Main conditions of life insurance contract in accordance with appendix to Board of Directors Decision: Parties:

Gazprom and SOGAZ-LIFE.

Beneficiary: insured person or persons designated by insured person as beneficiaries or insured person's heirs. Insurance premium under contract: RUB 24,289,438 (Twenty-four million two hundred and eighty-nine thousand four hundred and thirty-eight rubles).

Commencement and validity of Agreement: Agreement comes into force as of December 25, 2016 and remains effective until December 24, 2021 or until latest date of expiration of period of insurance coverage (inclusive).
