Brief description of event (action) which, if occurs (committed), has effect on value or quotations of issuer's securities, as deemed by issuer: <i>Gazprom obtained permission from Government Commission for Control over Foreign Investments in Russian Federation to fulfill obligations regarding Eurobonds without complying with provisions of clauses 4, 4(2) and 4(3) of Decree of President of Russian Federation No. 430 dated July 5, 2022 "On repatriation of foreign and Russian currency by residents who participate in international economic activity".</i> <i>In accordance with Decree No. 430, Gazprom fulfills obligations regarding Eurobonds by replacing them with replacement bonds of its subsidiary company, Gazprom Capital. Eurobond holders who have not replaced them will receive payments in line with credit and issuing documentation concerning Eurobonds.</i></p> <p>2.2.
