2. Contents of Statement

2.1. Class, category (type), series and other requisites of issuer's securities, on which revenues were accrued: certificated non-convertible interest-bearing bearer exchange bonds (hereinafter – Exchange Bonds), series BO-23, under mandatory centralized custody.

Amount of interest (coupon) on Exchange Bonds was determined by single executive body - Chairman of Gazprom Management Committee on July 24, 2018 (Order No. 429 dated July 24, 2018) in accordance with Securities Issue Resolution and Securities Prospectus approved by Gazprom Board of Directors' Resolution No. 1835, dated June 28, 2011, as amended by Gazprom Board of Directors' Resolution No. 2228, dated August 6, 2013, Resolution No. 2271 dated October 24, 2013, Resolution No. 2387 dated July 17, 2014 and Resolution No. 2388 dated July 17, 2014.

Content of decision made by single executive body of issuer:

To determine first coupon rate of certificated non-convertible interest-bearing bearer exchange bonds, series BO-23, under mandatory centralized custody, admitted to exchange trading in process of placement on August 10, 2011, identification number 4B02-23-00028-A (hereinafter - Exchange Bonds), as 8.10% (eight point ten) per year, which is equivalent to coupon yield for first coupon period in amount of RUB 40.39 (forty rubles, thirty-nine kopecks) per one exchange bond.

To set following coupon rates of exchange bonds: from second to fourteenth coupons as equal to interest rate of first coupon.
