Content of decision made by single executive body of issuer:

To determine first coupon rate of certificated non-convertible interest-bearing bearer exchange bonds, series BO-07, under mandatory centralized custody, admitted to exchange trading in process of placement on August 10, 2011, identification number 4B02-07-00028-A (hereinafter - Exchange Bonds), as 8.10% (eight point ten) per year, which is equivalent to coupon yield for first coupon period in amount of RUB 40.39 (forty rubles, thirty-nine kopecks) per one exchange bond.
