Content of decision adopted by issuer's Board of Directors:  <b>In compliance with Transaction Procedure approved by Gazprom Board of Directors Decision No. 366, dated September 27, 2002, Gazprom Board of Directors resolved to: Ratify acquisition of stake in equity capital of Gazprom Assets LNG by Gazprom through making additional contribution in amount of RUB 3,448,210,000 (Three billion, four hundred and forty-eight million, two hundred and ten thousand) in cash, following which nominal value of Gazprom's 100 per cent stake in equity capital of Gazprom Assets LNG will amount to RUB 22,924,819,000 (Twenty two billion, nine hundred and twenty-four million, eight hundred and nineteen thousand).</b></p> <p>2.3.
