Brief description of event (action) which, if occurs (committed), has effect on value of issuer's securities as deemed by issuer:</p> <p>Issuer's Report (Quarterly Report) of Gazprom for Q1 2020 was disclosed at date later than prescribed by Bank of Russia Regulation No. 454-П "On Disclosure of Information by Issuers of Registrable Securities" (hereinafter – Bank of Russia Regulation No. 454-П) dated December 30, 2014; however, it was disclosed within extended deadlines for information disclosure set up by decision of Bank of Russia's Board of Directors dated April 29, 2020, in accordance with Federal Law 115-FZ "On Introducing Amendments to Certain Legislative Acts of Russian Federation as regards Unification of Contents of Annual Reports of State Corporations (Companies), Public Law Companies, as well as Establishing Specifics of Regulation of Corporate Relations in 2020 and on Suspension of Provisions of Certain Legislative Acts of Russian Federation" dated April 7, 2020.</p> <p>Disclosure of information in form of issuer's report (quarterly report) within extended deadlines for information disclosure in line with decision of Bank of Russia's Board of Directors dated April 29, 2020 was due to external factors connected with restrictive measures aimed at preventing spread of new coronavirus infection (COVID-19). Most employees were shifted to remote (distance) work, which inevitably resulted in lengthened receipt and processing of documents and information necessary for compiling issuer's report (quarterly report).</p> <p>2.2.
