Content of decisions made by issuer's Board of Directors: To determine that based on market price calculated by National Rating and Consulting Agency, price of services indicated in Appendix to present decision to be equal RUB 167,864.41 (One hundred sixty seven thousand eight hundred sixty four rubles and forty one kopeks). To ratify signing of services agreement between Gazprom and Druzhba as transaction of corporate interest on terms listed in Appendix to present decision.</p> <p>2.3. Appendix to Board of Directors Decision No. 2302 dated January 22, 2014. Main terms and conditions of services agreement: Subject of agreement is rendering services on organizational and methodological support during trainings (holding of coffee breaks, leasing of premises and equipment for holding event, work of persons responsible for event) in IMPERIAL Park Hotel &amp; SPA hotel facilities. Period of rendering services: April 23-28, 2013. Agreement shall enter into force from date of its signing by parties and be effective until end of performance of obligations by parties. Terms and conditions of agreement are applied to relationship between parties from April 23, 2013.</p> <p>2.4.
