<p>On ratification of transactions, considered by Russian law as major transactions and (or) transactions of corporate interest</p>

Quorum of Gazprom Board of Directors and voting results on certain decisions: meeting in absentia, 11 out of 11 Board of Directors members submitted voting ballots, quorum recorded as present. Voting results on agenda items: <b>On ratification of transaction of corporate interest concluded with Gubkin Russian State University of Oil and Gas federal government funded institution of higher professional education</b> – In favor – 10 votes, Against – 0 votes, Abstentions – 1 vote.</p>

Content of decisions made by issuer's Board of Directors: To determine that based on market value calculated by Verum Est, price for services listed in Appendix to this Decision shall equal RUB 545,000 (Five hundred and forty five thousand). To approve that conclusion of Specialist in Liquefied Gases Production professional development training contract between Gazprom and <b>Gubkin Russian State University of Oil and Gas federal government funded institution of higher professional education</b> is transaction of corporate interest under terms listed in Appendix to this Decision.</p>
<p>2.3. Appendix to Board of Directors' Decision No. 2419, dated September 24, 2014. Main terms of services contract: Subject of agreement is provision of services for professional training of 1 (one) Gazprom's employee, Alexander Stroganov, under Specialist in Liquefied Gases Production professional training program, to acquire additional qualification of Specialist in Liquefied Gases Production, in form of postgraduate education with particular duration of 1,000 (One thousand) hours in person and in absentia. Period of services: from September 30, 2013 till November 21, 2014. Contract enters into force on date of its signing by parties and is valid until parties fulfill their obligations. Contract provisions, excluding those related to submitting information to Gazprom on alterations in University chain of ownership, are applicable to relationships between parties arisen since September 30, 2013.</p>
