Quorum of Gazprom Board of Directors and voting results on certain decisions: meeting in absentia, 11 out of 11 Board of Directors members submitted voting ballots, quorum recorded as present. Voting results on agenda items: <b>On ratification of transaction of corporate interest concluded with Gubkin Russian State University of Oil and Gas federal government funded institution of higher professional education</b> – In favor – 10 votes, Against – 0 votes, Abstentions – 1 vote.</p> <p>2.2. Content of decisions made by issuer's Board of Directors: To determine that based on market value calculated by Verum Est, price for services listed in Appendix to this Decision shall equal RUB 1,094,067 (One million ninety four thousand and seventy six) and 80 kopecks. To approve that conclusion of paid service contract between Gazprom and Gubkin Russian State University of Oil and Gas federal government funded institution of higher professional education is transaction of corporate interest under terms listed in Appendix to this Decision.</p> <p>2.3. Appendix to Board of Directors' Decision No. 2420, dated September 24, 2014. Main terms of services contract: Subject of agreement is provision of services for organizing and holding Tenth All-Russian Conference of young researchers, professionals and students New Technologies in Gas Industry (analyzing reports of conference participants and formulating proposals for further development of youth sci-tech activities; preparing and sending out newsletters to conference participants on conference date and venue; rendering organizational and methodical support to conference, including provision of conference participants with participant portfolios; organizing transportation services for conference participants; equipping conference rooms). Period of services: from October 8 to 11, 2013. Contract enters into force on date of its signing by parties and is valid until parties fulfill their obligations.</p> <p>2.4.
