- a) implementation of non-competitive procurement to ensure attainment of procurement share for domestic goods (including goods supplied for execution of procured works, rendering of procured services) established by Decree No. 2013;
- b) introducing requirement in course of purchases specified in sub-clause "a" of this clause, on availability of goods (goods) proposed (offered) for delivery in registers provided for in clause 2 of Decree No. 2013, and submission of information to procurement participants regarding number(s) of register entry(ies) made in respective registers;
- c), inclusion of number (numbers) of register entry(ies) of goods proposed for delivery by procurement participant into contracts awarded based on competitive tendering as specified in sub-clause "a" of this clause;
- d) imposing prohibition on replacement of good(s) contained in one of registers provided for in clause 2 of Decree No. 2013, by good(s) not contained in such registers during implementation of contracts awarded based on competitive tendering and specified in sub-clause "a" of this clause.
