Content of transaction, including civil rights and obligations being determined, modified or terminated by means of transaction: <b>Parties agreed to update Contract starting from January 1, 2019, namely, to put down new wording of first paragraph in clause 3.1 of Contract, which shall read as follows: "As at time of concluding Contract, its value shall be approximate in accordance with clause 4, Article 709 of Civil Code of Russian Federation, and shall constitute:</b>  - <b>RUB 251,509,048,246 (Two hundred and fifty-one billion, five hundred and nine million, forty-eight thousand, two hundred and forty-six) plus</b>  - <b>EUR 8,651,128,013 (Eight billion, six hundred and fifty-one million, one hundred and twenty-eight thousand, thirteen) plus</b>  - <b>CNY 5,263,773,234 (Five billion, two hundred and sixty-three million, seven hundred and seventy-three thousand, two hundred and thirty-four), in addition to VAT at rate determined in accordance with Russian legislation on taxes and fees.</b></p> <p>2.6.
