Brief description of event (action) which, if occurs (committed), has effect on value of issuer's securities, as deemed by issuer:</p> <p>Gazprom was notified that Gazprom Gerosgaz Holdings B.V. (Netherlands) and Rosingaz Limited (Rosingaz Limited) (Cyprus) ("Owners"), wholly-owned subsidiaries of Gazprom, had entered into share sale arrangement agreement, as well as brokerage agreements with Gazprombank (Joint Stock Company) with respect to sale of 693,627,848 ordinary registered uncertified shares of Gazprom (hereinafter - "Shares"), registration number 1-02-00028-A, dated December 30, 1998, via collecting and accepting bids for purchase of Shares using trading platform of Moscow Exchange (hereinafter – "Placement").</p> <p>Shares will be offered at same price and will be sold in their totality, partial sale of Shares is not envisaged. Sellers shall determine bids to be accepted, indicating bid's order rank, as well as number of Shares to be sold for each bid. They also decide on final allocation of Shares, or refuse to satisfy any bids. In latter case, all bids will be rejected. Collection of bids will be carried out on July 25, 2019, from 10.00 a.m. to 17.00 p.m. Moscow time. Results of bids collection will be announced upon completion.</p> <p>2.2.
