Brief description of event (action) which, if occurs (committed), has effect on value of issuer's securities, as deemed by issuer:</p> <p><b>Gazprom was notified that Gazprom Gazoraspredeleniye, company controlled by Gazprom ("Seller"), had entered into share sale arrangement agreement, as well as brokerage agreement with Gazprombank (Joint Stock Company) with respect to sale of 850,590,751 ordinary registered uncertified shares of Gazprom, registration number 1-02-00028-A, dated December 30, 1998 (hereinafter – "Shares"), via collecting and accepting bids for purchase of Shares using trading platform of Moscow Exchange (hereinafter – "Placement").</b></p> <p><b>Shares will be offered at same price and will be sold in their totality; partial sale of Shares is not envisaged. Seller shall determine bids to be accepted, indicating bid's order rank, and number of Shares to be sold for each bid, as well as will decide on final allocation of Shares, or refuses to satisfy some bids. In latter case, those bids will be rejected.</b></p> <p><b>Collection of bids will be carried out on November 21, 2019, from 10.00 a.m. to 05.00 p.m. Moscow time. Results of bids collection will be announced upon completion.</b></p> <p>2.2.
