Results of selling ordinary registered uncertified shares of Gazprom.

Gazprom was notified that on November 22, 2019, Gazprom Gazoraspredeleniye ("Seller"), company controlled by Gazprom, had successfully completed sale of 850,590,751 ordinary registered uncertified shares of Gazprom (hereinafter - "Shares"), registration number 1-02-00028-A, dated December 30, 1998, via collecting and accepting bids for purchase of Shares using trading platform of Moscow Exchange (hereinafter - "Placement").

Upon completion of Placement, Seller will no longer have shares of Gazprom.

Sale price was set at RUB 220 and 72 kopecks per Share. Shares sold represent 3.59% of Gazprom's voting shares. Free float of Gazprom is 49.61% of share capital after completion of Placement.
