Description of contract: provision of services for arranging and holding International competition of student projects and projects of young specialists in honor of UGS 100th anniversary. Total cost of services including VAT is RUB 1,490,420 (One million four hundred ninety thousand four hundred twenty) 24 kopecks. Terms of service: from August 28, 2014 until November 16, 2015. Agreement enters into force on date of signing by parties and is valid until parties fulfill their obligations. Contract conditions, except for conditions on information disclosure to Gazprom about changes in University chain of ownership, apply to parties' relations established from August 28, 2014.
