Contents of transaction, including civil rights and obligations being determined, modified or terminated by means of major transaction: <b>Pursuant to Gas Supply Agreement No. 101000 dated August 1, 2022, Supplier undertakes to transfer combustible gas (natural and/or associated petroleum gas and/or dry stripped gas, and/or gas produced from gas condensate fields) (hereinafter referred to as "Gas"), into ownership of Buyer, with delivery at address of Consignee (Novo-Salavatskaya CHPP, INN: 0266029390, OGRN: 1070277006480), and Buyer undertakes to accept (offtake) gas in agreed volumes and pay for it.</b>
2.6. Parties and beneficiaries of major transaction: <b>Gazprom Mezhtregiongaz Ufa as Supplier.</b> <b>Gazprom Neftekhim Salavat as Buyer.</b>
2.7. Deadline for performing obligations under major transaction: <b>Agreement shall remain in effect until December 31, 2028, and in part of settlement of accounts – until its full implementation by Parties.</b>

2.8. Value of major transaction in monetary terms and as percentage of value of assets owned by entity controlled by issuer and materially important for issuer: **RUB 56,150,414,451.65 including VAT, which equals 23.49% of assets value.**
